A Statement read by Board President Kristin Lyle:

At the August 11th school board meeting, a certified teacher was denied a supplemental contract by a vote of 2-5. The day and days following that board meeting, several conversations have ensued creating a concern of potential inappropriate board member behavior.

It appears, with evidence, that "executive session" conversation and information is being discussed outside of executive session and is a violation of board member conduct.

On Tuesday morning, August 12, a student approached a teacher in their classroom to ask if they had heard about what happened the night before in executive session. The student went on to paraphrase board conversation that took place in the publicly closed executive session. It is difficult to understand how this could happen without a board member having shared this confidential information.

Another teacher, uninvolved in the situation described, contacted a board member to express concern for perceived inappropriate board member behavior as it diminishes board credibility and creates a lack of trust teachers may develop on behalf of the school board as a whole.

It is also noted that at least one board member has been heard making personal comments about staff members to other board members and has engaged with members of the community as well. These comments may be opinion, unfounded or untrue. They can be hurtful and inappropriate when shared by an elected official charged with creating board policy, approving budgets and hiring the superintendent. School boards function as a local governing body, working as a team with the superintendent to make decisions impacting the school environment and student education.

Board members are not involved in day-to-day operations of the schools. Board members should direct concerns to the superintendent for any staff or student issue for the superintendent to handle.

Continued instances like these negatively impact our staff, students, district, and the trust of fellow board members. It also inhibits effective team work, along with reluctance to contribute to executive session discussions. Past efforts have been made to address these behaviors privately. However, due to the repeated occurrence, the issue is being publicly addressed.
